



PARENTAL CONSENT FORM
For Children Under 18 Years of Age

NOTICE TO PARENTS AND LEGAL GUARDIANS

This notice is to inform you that your child wishes to use Resiliency Technologies's services called "Sharpen" or "Sharpen DTX" ("Services"). This form explains what information we collect from children under 18, how we use that information, and your rights as a parent or legal guardian.

INFORMATION WE COLLECT

We may collect the following information from your child:

- Name and age
- Email address
- Username and password
- Profile information
- Usage data and activity within our Services

HOW WE USE THE INFORMATION

We use your child's information to:

- Provide and maintain our Services
- Communicate with your child about their account
- Ensure safety and security of our platform
- Comply with legal obligations
- Improve the Services being provided to your child

DISCLOSURE OF INFORMATION

We do not sell, rent, or otherwise disclose your child's personal information to third parties except:

- With your additional consent
- To service providers who assist us in operating our Services
- When required by law
- To protect the safety and security of our users

YOUR RIGHTS AS A PARENT/GUARDIAN

You have the right to:

- Review your child's personal information
- Request that we delete your child's personal information
- Refuse to allow further collection of your child's information
- Request that we stop using your child's personal information



PARENTAL CONSENT
